We may collect the following types of information:

**Personal information** (name, email, phone number) when you register as a member, volunteer, donor, or when you contact us.

**Technical information** (IP, browser, operating system) through cookies and analysis tools.

**Documents, images, or complaints** sent through protected forms.

### 3. How do we use your information?

We use the data only for institutional and legitimate purposes, such as:

- Communicate with you in response to your requests.
  - Manage access to protected areas or members-only content.
  - Send newsletters, alerts, and calls (if you have given your consent).
  - Ensure the digital security of communications and complaints received.

### 4. How do we protect your data?

We implement technical and organizational measures to ensure the security, confidentiality, and integrity of your data, including:

- Communications encryption (SSL)
  - Forms protected by authentication
  - Restricted access and differentiated roles on our platforms
  - Internal digital security policy

### 5. Who do we share your information with?

**We do not share your data with third parties** unless legally required or with explicit consent. In exceptional cases, we may collaborate with partner organizations under confidentiality agreements and for protection or humanitarian response purposes.
